COMMERCIAL BOOTHS

"Come for the Fair.....Stay for the Fun!"

You are invited to join us at the 2010 Woodbury County Fair that will be held August 4 thru August 8, 2010 in Merville, Iowa.

Booth Space Options:

1. 8' wide X 10' deep, **indoor air conditioned**, well lighted. **Cost: \$150.00**
2. 8' wide X 10' deep, **indoor non-air conditioned**, well lighted. **Cost: \$50.00**
3. 15' wide X 20' deep, **outdoor**, **Cost \$50.00, plus \$15 for electricity if needed.**

Electric Outlet: Furnished for each space for indoor booths, and is \$15.00 additional for outdoor if needed.

Exhibitor furnishes all other equipment and supplies.

Each Exhibitor to have their own insurance covering liability, property damage and product liability.

No soliciting or advertising is permitted outside the booths.

SET UP: Tuesday, August 3, 2010

TAKE DOWN: 6:00 p.m. Sunday, August 8, 2010

OPERATION HOURS:
Wednesday & Thursday – 12 noon – 9:00 p.m.
Friday & Saturday – 10:00 a.m. – 9:00 p.m.
Sunday – 12 noon – 6:00 p.m.

SET UP DAY: Please come to the Fair Office to get space location, and 2 passes to admit you and a helper to the grounds. Any additional tickets can be purchased at the office; season tickets are \$10.00 each, daily admission is \$4.00.

All vehicles must be left in the parking lot Wednesday through Sunday. If delivery into the fairgrounds is necessary, please come to the fair office for an auto pass. Vehicles must be removed to the parking lot as soon as deliveries are made.

Buildings will be locked at night and security provided, this includes Sunday night, allowing booth displays to be left until Monday if you wish.

The Woodbury County Fair reserves the right to be selective in determining which products or exhibits are granted booth space. Criteria used may include, but not be limited to, space available, several duplicate exhibitors, appropriateness for family fair or health and safety of fair visitors.

You MUST complete, sign and return the enclosed Commercial Booth Lease, along with your payment for the booth/booths and the completed Waiver and Indemnification Agreement by June 15. This will ensure that you have your space reserved. After June 15 we will contact those on the waiting list to rent a booth space.

Past commercial exhibitors have expressed to us that it has been very profitable for them to exhibit at the Woodbury County Fair. We look forward to making the 2010 Woodbury County Fair a success.
