ATV BARREL RACING

RULES

GENERAL INFORMATION:

- \$1000 added money! division of entry fees
- Classes will include: 2 wheel drive atv, 4 wheel drive atv, side by side, and motorcycle, A Drag class may be added, match format if there is enough room otherwise it will be timed, judges will have final say on class qualifications.
- Entry fee will be \$10 for each class per run (limit 2 runs per class) A practice runs will be allowed prior to racing alternating turns.
- Each contestant will be given a number (will be used for the whole year) and can only be used by that individual, use by any other will end up with both parties being disqualified . Vehicle can be used multiple times per qualified class
- No added weight will be allowed
- all riders must be 16 years old or older (parent or guardian must sign consent for those under 18)
- all contestants must release liability and attend drivers meeting before allowed to compete
- 1st, 2nd, and 3rd place will be paid back in each class, judges reserve the right to adjust number of placings paid in each class based upon number of entries. (1st- \$125, 2nd-\$75, 3rd-\$50, plus division of entry fees)
- a panel of judges will review all scenarios not covered by listed rules
- all decisions by judges are final
- riders will conduct themselves in a respectful manner and remain in control of their machines during operation, reckless behavior or intoxication will end up in disqualification
- No alcohol allowed in pit area
- DOT approved helmets, covered toed shoes must be worn by contestants, long sleeve shirt, long pants, and eye protection, boots and Hand protection is encouraged
- There will be a final race of the series held at the Sac County Fair Grounds August 24th 3:00pm
- 20 points need to be earned to qualify for finals(Attend 2 events minimum)
- Points will be awarded towards series finale : 1st- 10 points
 - 2nd- 9 points
 - 3rd- 8 points
 - 4th- 7 points

5th - 6 points

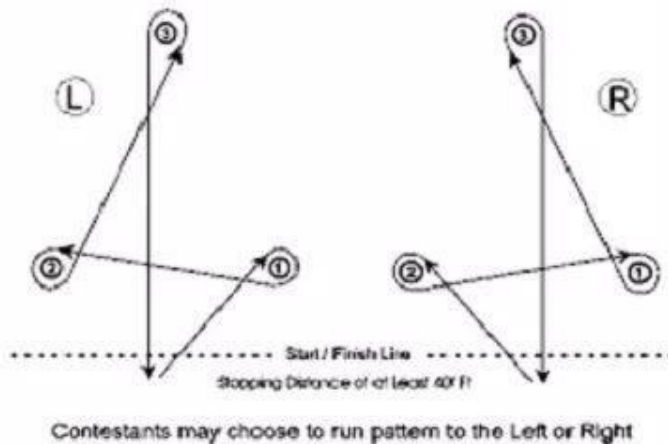
Every other contestant that finish - 5 points

-Each board will add \$500 added money for finals; (5 events X \$500= \$2500) added money with a 100% payback

-\$10 entry fee per class in finals, limit 2 entries per class
